#### **Candidate Statement**

#### What are the three or four issues facing Winchester that you think are most important?

- Affordability both property taxes and housing prices
- Economic development
- Communication & community engagement

#### What are your positions on these important issues?

- Winchester has many assets: a reputable school system, a quaint town center with historic structures, natural resources, and picturesque neighborhoods, all within an easy commute to Boston, making it a highly desirable (and expensive) community. Our tiny commercial tax base, and our low state aid pushes up property taxes to among the top 10 in the state, making Winchester unaffordable for young adults (25-35) and seniors who may wish to downsize. As a community so close to the city, we must prioritize and think creatively about the mix in our housing stock and zone for development that effectively balances the town's historic character with affordabilty.
- The Town's 2030 Master Plan identifies a number of regions for smart grown opportunities that we should be actively pursuing to support our current town businesses and attract new or entrepreneurial business investment and encourage mixed-use (commercial-residential) development that support Winchester's neighborhoods. It is important to provide adequate staffing to the Town Planning Department to be able to

envision and implement policies to sustain a viable business sector, so I support the addition of an assistant town planner as part of our Spring Town Meeting budget.

 I served as Vice Chair of the Communication Study Committee (CSC), which made recommendations for ways that town hall and town meeting could improve communication between town committees and boards and also with residents. I currently serve as Vice Chair of the Winchester Town Meeting Members Association (https://www.winchestertmma.org), which was one of CSC's recommendations. Winchester's Town Manager is now working on a Communication Plan. Modernizing our communication efforts will always be important to effective governance.

# Do you support Winchester adopting the Community Preservation Act? What reasons do you have for your position?

Fall Town Meeting 2023 was presented with a description of the CPA by a study committee appointed by the Select Board, which announced it would be conducting public information sessions with residents and stakeholder groups prior to spring town meeting on how it would work. These communications have not materialized, so I while I am very open to supporting the CPA, I'd like to see more specifics before taking a position on adding a CPA surcharge to our residential taxes.

With or without the CPA, Winchester will need to pass overrides for urgent needs in capital/building maintenance, operating budget, and the Muraco school renovation. I feel it's important for town meeting to understand the vision for CPA uses in Winchester, and how administrative oversight would work in tandem with current processes.
