- Addressing pedestrian/bike safety and traffic calming measures

What are your positions on these important issues?

I believe our most valuable asset in Winchester is our public schools. As such we must support high quality education by ensuring proper funding of the school budget. In particular I am very concerned about the early literacy curriculum. This issue has been ignored for several years and I believe a significant investment in this area is needed.

In our neighborhood specifically, careful attention will be needed as Eversource completes the 345 kV line and begins restoration work along Cross (and Washington) Streets this spring, **keeping public safety at the forefront**. As the River Street apartments open we will need to monitor vehicle/pedestrian/bike traffic impacts and if current crosswalks and traffic controls are sufficient.

As a bedroom community we must be smart with our spending and find ways to stretch our dollars as far possible by seeking opportunities for outside funding and matching grants. Looking at ways to responsibly grow the business tax base should continue to be explored.

Do you support Winchester adopting the Community Preservation Act? What reasons do you have for your position?

Yes, I support Winchester adopting the Community Preservation Act. It will help our tax dollars go farther by enabling the town to take advantage of matching funds from the state for projects that we are already planning on doing.
